REPORT OF THE PRESIDENT: The Personnel Committee gave JL her Director's Evaluation. JL will be working to update Board binders. JL is in the process of scheduling a speaker to discuss the Library Statute with the Board.

REPORT OF THE DIRECTOR: Monthly report and monthly statistics report given by JL. FPL will be participating in two outreach events in early March: The High School Multicultural Fair and a PTA Literacy Night at Pleasant View Elementary. JL will explore the possibility of developing a project to submit for funding under the Library Services and Technology Act Grants to States program for 2020.

REPORT OF THE FRANKLIN LIBRARY FOUNDATION: The Foundation continues to work on the legality of the Foundation to accept private grant funds.
