- I. Approval of the Minutes from the Regular Meeting of the Board of Trustees on January 25, 2021
  - a. AV moved to approve minutes; JM seconded. Motion carried.
- II. Finance Committee – A. Aleksandrowicz
  - a. Approval of Vouchers and Invoices - Only concern was MCFLS invoice. Discussed Nintendo Switch games and checking out of the same. AV moved to approve invoices in amount of \$67,011.94; MK seconded. Motion carried.
  - b. Treasurer’s Report - Library has received money in Fund 15 from property taxes. Checking with city on holidays for expenses. Part of maintenance expenses result from Bibliotheca one-time fee regarding maintenance agreement for security gates and checkout stations. Fund 16 - No info because nothing posted. Will have information next month. WaterStone and donations are in-line with expectations, but should analyze fees versus interest for WaterStone.
- III. Business:
  - a. Discussion and Approval of 2020 Franklin Public Library State Annual Report - We needed to provide more information this year because of virtual programming. AA moved to approve the 2020 Franklin Public Library State Annual Report; MI seconded. Motion carried.
  - b. Discussion and Approval of Statement Concerning System Effectiveness - Discussed what MCFLS has done this year for library. MK moved to approve statement that Franklin Public Library Board of Trustees hereby states that the Milwaukee County Federal Library System did provide effective leadership and adequately met the needs of the library; AA seconded. Motion carried.

- c. Update on Library Services During Covid-19 - At this point more staff are vaccinated. The Library plans to start to increase hours and open on Sundays. Services will be increasing to close to pre-pandemic levels.

- V. Update on Franklin Public Schools Matters Relating to the Library – J. Mueller - No items really relating to library. School personnel awaiting vaccinations.

Met with Jennifer on February 15 to discuss goals and compensation. Understand City Council is considering citywide pay increase in May that will be voted on as well as potential merit increases. Discussed raise process for employees and City's involvement.

  - a. Monthly Activity of Library Director & Library – Have promoted a Library Shelver to Library Clerk. Have discussed possibly hiring summer intern. Working on strategic plan goals and master calendar. Still working on doors. Did need to use almost \$15,000 of fund balance last year. Discussed status of review of facilities by City.
  - b. FPL @ a Glance Statistics Report - Discussed circulation and comparisons to services provided by other libraries and ways to increase library patrons.
- IX. Report of the Franklin Public Library Foundation – J. Loeffel & A. Vitas-Oklobdzija - No meeting, but Great Decisions is occurring and three programs have been held so far. First two were fine; last one was problem with passcode. No longer requiring passcode. Next Wednesday at 6:30p.m. we have a new speaker which should be interesting.
